Membership Registration Process for 2025 – Register Now.

The International Society wishes to have access to all of the details of all members worldwide through the isrp.com website. To achieve this, from this year, the registration process will be completely handled through isrp.com. Some of you have pre-empted this newsletter by working it out for yourselves so the process must be intuitive.

Previously, even if the member registered via isrp.com, we have taken payments locally via a second registration to isrp europe.com. Those who visited isrp europe.com first could, if they wished also register at isrp.com. In both cases the European Secretary had then to confirm to isrp.com that payments had been made.

These are the steps to be followed now:-

- Visit www.isrp.com. If you have been there before you will notice a difference.
- If you have registered there previously click on the human head and torso type symbol at the top right. You can then enter your user name and password. If you have never registered there before scroll right down to the bottom of the page and click on “Join ISRP” at the bottom right.
- You can also start at <https://www.isrp.com/european/> which takes you a little further into the system but you will still have to start afresh if you’ve never registered here.
- Either way you will reach the following page:-

Here you can click on subscribe. The Individual membership route is working. You will be asked to check some details. You will, I hope opt in to getting the section newsletters. You can opt in to joining the member's directory. Those of you who have been members for years will remember that we used to publish a booklet of member's names and contact details, which we stopped following the adoption of GDPR.

The corporate membership route will work but at the moment the member paying the fee will be registered as the corporate member and two codes will be sent so that other corporate members can register themselves under the Additional Annual Corporate Membership (not quite all on my screenshot above) route for free. Two codes are sent in case the person paying the fee is not going to be an active member (i.e. an accountant).

e. Payment can then be made by credit card through Stripe and this payment goes directly to the European Section as before. If you opt to pay offline a note will be sent to the Section Secretary and he will have to send you an invoice with our bank details for BACS payments as previously. We are hoping that sending this invoice can be automated in future.

f. An acknowledgement should then be sent.
